

STEP-BY-STEP GUIDE FOR THE SPAIN DIGITAL NOMAD

To get a Spain Digital Nomad Visa, you will need to meet the following requirements:

- Be a national of a non-European country and be at least 18 years old.
- Have a passport valid for at least 1 year.
- Have been working for at least 3 months for a company based outside Spain.
- Proof that you can work fully remote.
- Proof of higher education or at least 3 years of work experience.
- Have a clean criminal record.
- Have private or public health insurance that covers you for the duration of your stay in Spain.
- Demonstrate that you have sufficient earned income. This means having an income of at least 200% of the Spanish minimum wage (2,250 euros per month/ 30,240 euros per year).



Application process

There are two ways to apply for the Spain digital nomad visa:

- From outside Spain: You can apply for the visa at the Spanish embassy or consulate in your home country.
- From inside Spain: If you are already in Spain on a tourist visa, you can apply for the visa online at the Spanish immigration office.

Step-by-step guide to applying for the Spain digital nomad visa (**from inside Spain**)

- Submit your online application through a Spanish immigration lawyer at the Spanish immigration office.
- Submit the following documentation to the immigration office online portal:
 - A completed application form.
 - A copy of your passport.
 - Your CV to prove your work experience.
 - A copy of your health insurance policy.
 - Proof that you are in Spain at the time the application is submitted.
 - A letter from your employer or client confirming that you are a digital nomad and you can work remotely from Spain.
 - Documentacion from the company you work for.
 - Your last 3 invoices or payslips.
 - A criminal record certificate from your home country.
 - Proof of higher education or at least 3 years of work experience.
 - Bank statements from the last 3 months.
- Pay the application fee.
- Wait for a decision from the Spanish government.

From outside Spain

To apply for the visa from outside Spain, you will need to follow these steps:

1. Make an appointment at the Spanish embassy or consulate in your home country.
2. Submit the required documentation to the embassy or consulate.
3. Pay the application fee.
4. Wait for a decision from the Spanish embassy or consulate.

The documentation to be submitted is almost the same as that required when applying for the visa from within Spain, but be sure to check with the Consulate or Embassy beforehand in case the documentation differs.

Each Embassy reserves the right to request additional documentation that it deems necessary for the granting of the visa.

Once your application has been approved, you will be issued a digital nomad visa for 1 year and after that you can renew it for more time once in Spain.
